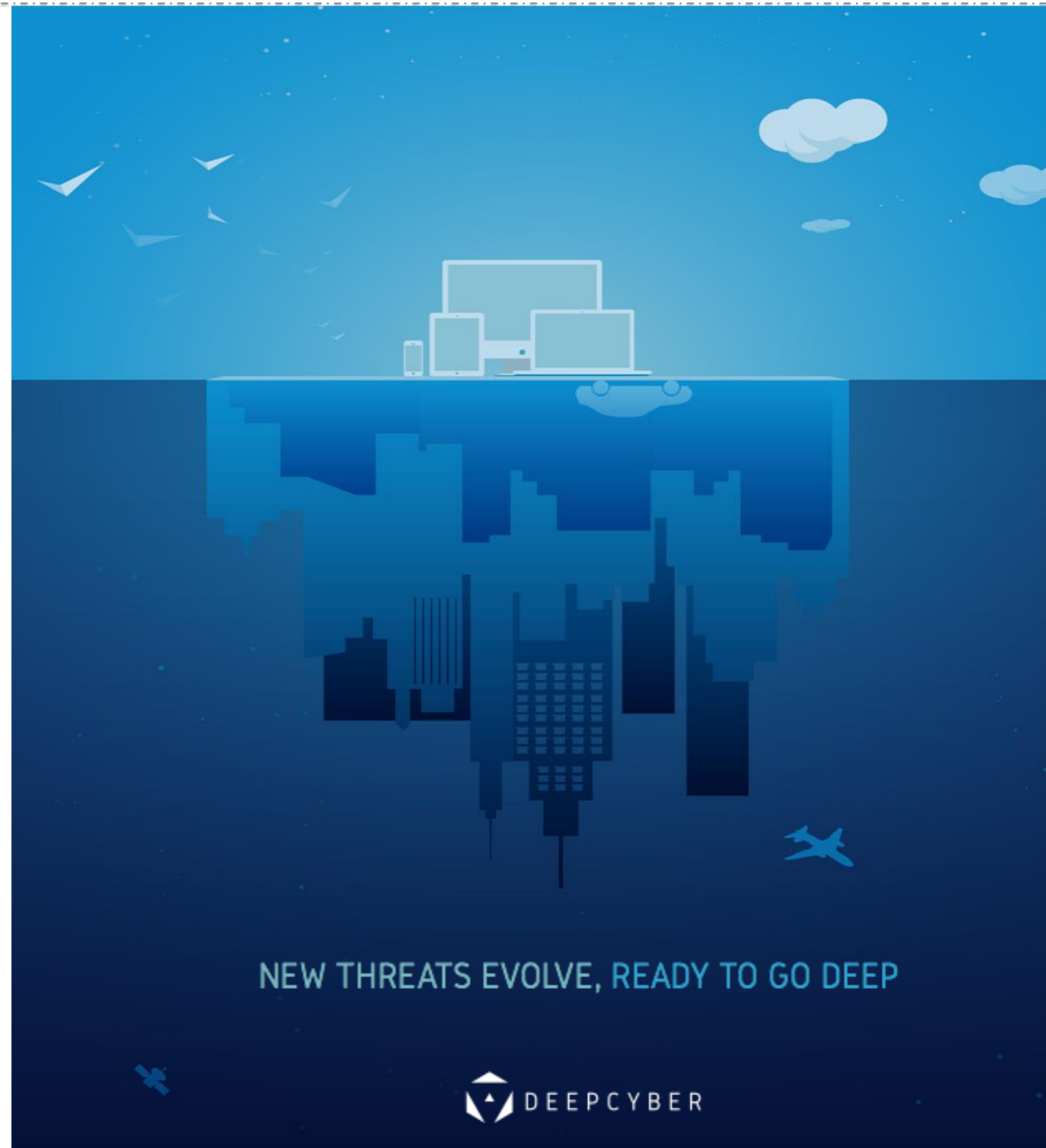
## Protection

# 1. Cyber Threat Intelligence

## Custom Cyber Threat Monitoring Services

## Cyber Threat Intelligence Feed & Platform

Support service for the acquisition and use of Cyber Threat Intelligence feeds and platforms.

## Cyber Threat Report

Reporting service on a monthly or quarterly basis on the main threats on the surface, deep and dark webs.

## Cyber Threat Hunting

A customer support service which deploys a specialised Cyber Threat Hunting team to improve the integration of Cyber Threats with the SOC. Support for the continuous management of Intelligence information, through validation and periodic reporting of actual threats.

## Bitcoin Intelligence

Monthly support and reporting related to money transfers from bank accounts to Wallets and Exchange Platforms using Cryptocurrencies (Bitcoin, Litecoin, Ethereum).

### Data Protection

Data Protection Assessment Service, Data Breach Investigation - Risk & Vulnerability Analysis, DPIA, and support for GDPR regulatory compliance

### Brand Protection Intelligence

A service for the collection, identification and analysis of information from various sources on the web and the deep & dark webs, to determine if a site is hostile or fake. Report generation. Monitoring and recommendations

### Forensic IT and Incident Response

A data analysis service which uses forensic methods and provides Incident Response support

### Reputation Intelligence

A service for the research and analysis of third party entities in matters of regulatory compliance e.g. anti-corruption, AML, digital risk and business risk

### Data Encryption

Distributor of encrypted devices (with Pins or Biometrics) providing data protection in GDPR contexts

### Attack and Phishing Simulator

Advanced training services for the prevention, identification and management of Cyber threats and Anti-Fraud, through latest-generation "simulators" of cyber attacks or supervised phishing campaigns

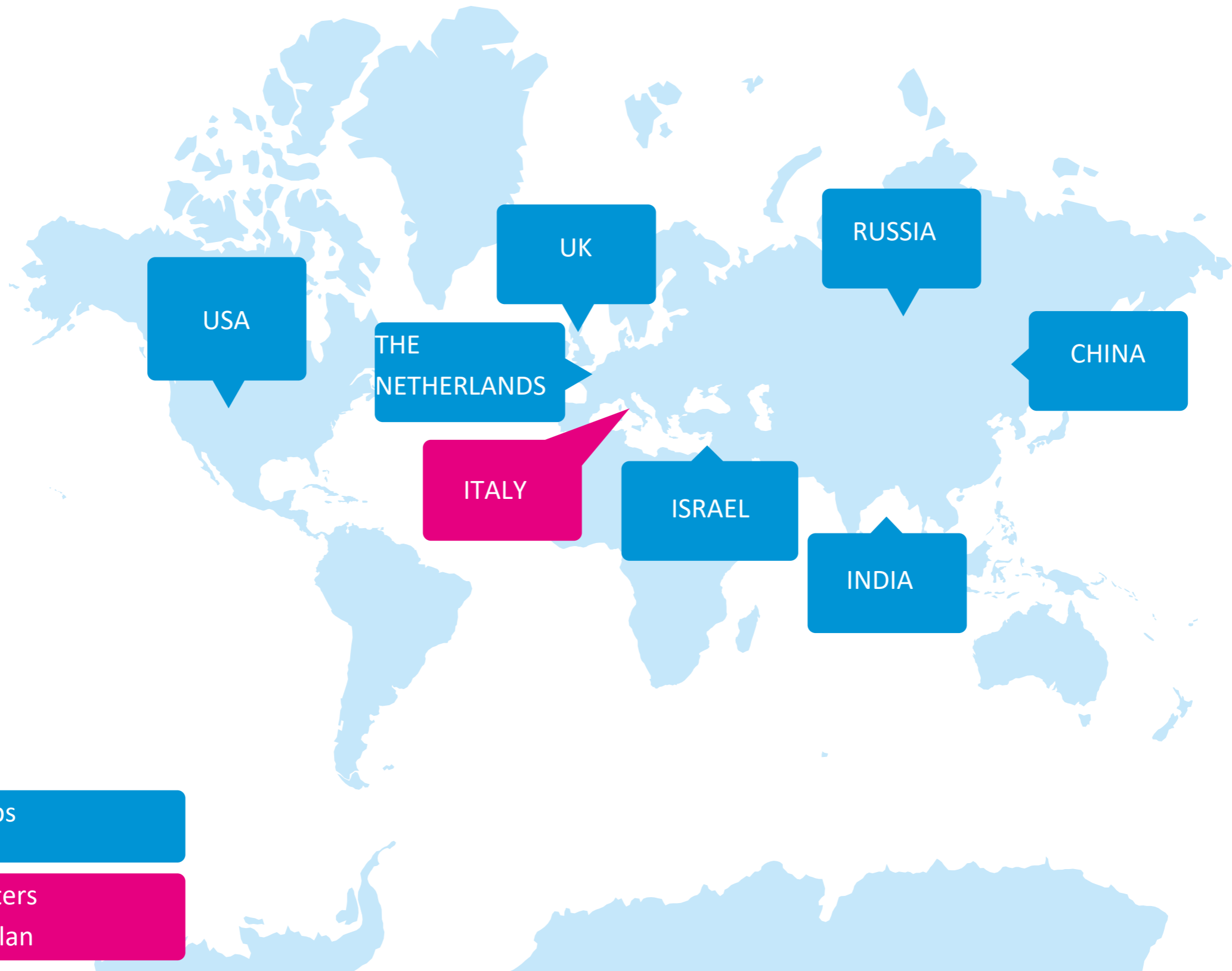
