Personal Data Protection Law No. 6698 (“**KVKK**”) has given the right to make certain demands regarding the processing of personal data.

Siemens Enerji Sanayi ve Ticaret Anonim Şirketi (“**Siemens Enerji**” or “**Company**”), evaluates the rights of the data subjects arising from their titles of data ownership and the information to be made to the relevant persons, can be made through this Related Person Application Form in accordance with KVKK Article 13.

2. Application Rights and Method

Applications of the relevant persons regarding their rights arising from KVKK, must be submitted to us in writing accordance with Article 13 of the KVKK or by other methods to be determined by the Personal Data Protection Board (“**Board**”).

4.1. Exceptions of the Application Right

In accordance with Article 28 of the KVKK, the persons concerned will not be able to assert their rights in the following cases:

- (1) Processing of personal data by real persons within the scope of activities related to themselves or their family members living in the same residence, provided that they are not given to third parties and that the obligations regarding data security are complied with,
- (2) Processing personal data for purposes such as research, planning and statistics by making them anonymous with official statistics,
- (3) Processing of personal data for art, history, literature or scientific purposes or within the scope of freedom of expression, provided that it does not violate national defense, national security, public security, public order, economic security, privacy of private life or personal rights or does not constitute a crime,
- (4) Processing of personal data within the scope of preventive, protective and intelligence activities carried out by public institutions and organizations authorized by law to ensure national defense, national security, public security, public order or economic security,
- (5) Processing of personal data by judicial authorities or execution authorities in relation to investigation, prosecution, trial or execution proceedings.

In accordance with paragraph 2 of Article 28 of the KVKK, it will not be possible for the persons concerned to assert their rights (with the exception of the right to demand compensation):

- (2) The processing of personal data is necessary for the prevention of crime or for criminal investigation.
- (3) Processing of personal data made public by the person concerned.
- (4) If the personal data processing is required by the authorized and authorized public institutions and organizations and professional organizations in the nature of public institution, for the execution of inspection or regulation duties and for disciplinary investigation or prosecution, based on the authority given by the law.
- (5) The processing of personal data is necessary for the protection of the economic and financial interests of the Country with regard to budget, tax and financial matters.

5. Our Company's Response Procedure and Time Period for the Applications

In accordance with Article 13 of the KVKK, our Company will conclude the application requests made by the relevant person to our Company as soon as possible and within 30 (thirty) days at the latest, depending on the nature of the request, free of charge. However, if the transaction requires an additional cost, the fee in the tariff determined by the Board may be requested from the persons concerned.

In order to ensure the security of your personal data, our Company may request information from the applicant for identification and authorization purposes.

The application of the person concerned may be rejected in the following cases:

- (1) Inhibiting the rights and freedoms of other persons
- (2) Requires disproportionate effort
- (3) If the information is publicly available information
- (4) Endangering the privacy of others
- (5) Existence of one of the situations out of scope pursuant to KVKK

6. The Right of the Relevant Person to Make a Complaint to the Board

In accordance with Article 14 of the KVKK, in cases if the application is rejected, the response is found insufficient, or the application is not answered in time, the person concerned may file a complaint with the Board within 30 (thirty) days from the date of our Company's response and in any case within 60 (sixty) days from the application date.

No complaint can be made to the Board before an application is made to our company.
